

## PRODUCTS/SERVICES IN SUPPORT OF A U.S. GOVERNMENT CONTRACT

For purchase orders placed by Trellix with Supplier in support of and charged to a U.S. Government (“Government”) prime contract or higher-tier subcontract for an item meeting the Federal Acquisition Regulation (FAR) definition of a commercial item, the following provisions and clauses set forth in the FAR or the Defense Federal Acquisition Regulation Supplement (DFARS) shall apply.

The term “FAR” and “DFAR,” when used in the following provisions, means the cited portion of the Federal Acquisition Regulations and Defense Federal Acquisition Regulations (which can be found at: <https://www.acquisition.gov/>). Whenever necessary to make the context of the FAR or DFARS clauses applicable, the term “Contractor” shall mean You, the term “Contract” shall mean Your applicable contract, and the term “Government,” “Contracting Officer,” and equivalent phrases shall mean Trellix. For the avoidance of doubt, the words “Government” and “Contracting Officer” do not change: (1) when a right, act, authorization, or obligation can be granted or performed only by the Government or the prime contract Contracting Officer or duly authorized representative, such as in FAR 52.227-1 and (2) when title to property is to be transferred directly to the Government. Nothing in the purchase order grants Supplier a direct right of action against the Government. If any of the following FAR or DFARS clauses do not apply to the purchase order, such clauses are considered to be self-deleting. Supplier shall incorporate into each lower tier contract issued in support of the purchase order all applicable FAR and DFARS clauses in accordance with the flow down requirements specified in such clauses.
